The proposals are:

### <u>Proposed Total Prohibition of Waiting – No Waiting at Any Time</u>

<u>Lode Lane service road (adj. 303) (northeast side)</u> - From a point approx. 45m southeast of its junction with Henley Crescent to its junction with Lode Lane.

<u>Lode Lane service road (adj. 303) (southwest & southeast side)</u> - From a point approx. 47m southeast of its junction with Henley Crescent to its junction with Lode Lane.

<u>Lode Lane service road (adj. 305) (both sides)</u> - From its junction with Henley Crescent, south-eastwards for approx. 15m.

<u>Lode Lane service road (adj. 307) (both sides)</u> - From its junction with Henley Crescent, northwestwards for approx. 10m.

<u>Henley Crescent (both sides)</u> - From a point approx. 9m southwest of its junction with Lode Lane, south-westwards for approx. 23m

<u>Henley Crescent (northwest side)</u> - From a point approx. 15m northeast from its junction with Rowlands Crescent, south-westwards for approx. 30m.

Rowlands Crescent (both sides) - From its junction with Henley Crescent, north-westwards for approx. 12m.

## Proposed Restriction of Waiting - Limited Waiting - 2 Hours No Return Within 2 Hours

<u>Lode Lane service road (adj. 303 – 305) (northeast side)</u> - From a point approx. 15m south of its junction with Henley Crescent, south-eastwards for approx. 30m.

<u>Lode Lane service road (adj. 303 - 305) (southwest side)</u> - From a point approx. 15m south of its junction with Henley Crescent, south-eastwards for approx. 32m.

#### Proposed Restriction of Waiting - No Waiting Monday to Friday 0900 to 1100 and 1400 to 1500

<u>Lode Lane (adjacent to 357 - 369)</u> - From a point approx. 7m west of its junction with Lode Lane for the entirety of the cul-de-sac.
