			7.9.2 The site performs relatively well against most of the criteria in Policy P6 of the Solihull Local Plan. There are no significant highway issues and, whilst public transport is not readily available within the immediate vicinity of the site, most facilities and services are located within a realistic walking distance. Although there are no public views of the site, it is located within a sensitive Green Belt location. An extension of the site would have an urbanising effect on the attractive rural landscape, particularly when considered cumulatively with the neighbouring authorised Gypsy and Traveller site at Salter Street. For this reason, it is considered that only a modest intensification			






Appendix 1 - Map for Policy GTS 2 - Old Damson Lane




Appendix 2 - Revised Map for Policy GTS 4 - The Uplands




Appendix 3 - Map for new Policy GTS 6 - Canal View




Appendix 4 - Revised Map for Policy GTS 7/4 - The Warren, Marston Green (6 pitches)
