1. Assessing Land Availability

Introduction

- 1. In 2015 the Council resolved to undertake a review of its local plan. Although the Solihull Local Plan (SLP) was only adopted in December 2013, a number of factors have triggered the need for an early review.
- 2. The first stage in undertaking the review was the publication in November 2015 of a "Scope, Issues and Options Consultation¹". This was open for consultation from 30th November 2015 to 22nd January 2016. A summary of the representations to the consultation and the Council's response to them can be found on the Council's web site.
- 3. The second stage of the review was the publication in December 2016 of the "*Draft Local Plan*²". This was open to consultation from 5th December 2016 to 17th February 2017. A summary of the representations to the consultation is being made available by the Council.

Call for Sites

- 4. In parallel to the November 2015 consultation on the Scope, Issues and Options for the review, the Council also invited landowners (or others wishing to promote a site) to make submissions through a 'call for sites' exercise. This would help identify what land <u>may</u> be available for development over the plan period. Submissions made at this stage would not necessarily mean that they would be considered suitable for development, but it would allow for a comprehensive assessment to be undertaken of them.
- 5. A schedule of all the sites put forward through the November 2015 'Call for Sites' exercise was published in May 2016³ and this can be found on the Council's web site.
- 6. Through the publication of the Draft Local Plan in December 2016, a number of additional sites have been put forward by those either promoting a site that they consider suitable for development or by others who may think an alternative site is preferable to one or more of the Council's preferred options included in the Draft Local Plan. The purpose of this present document is to update the earlier schedule to include those additional sites that have been promoted since May 2016; including those put forward as a result of the Draft Local Plan consultation.

Strategic Housing and Economic Land Availability Assessment (SHELAA)

- 7. An assessment of land availability identifies a future supply of land which is suitable, available and achievable for housing and economic development uses over the plan period. The assessment of land availability includes the Strategic Housing Land Availability Assessment (SHLAA) requirement as set out in the National Planning Policy Framework⁴.
- 8. The assessment of land availability is an important step in the preparation of Local Plans. The National Planning Policy Framework identifies the advantages of carrying out land assessments for housing and economic development as part of the same exercise, in order that sites may be allocated for the use which is most appropriate.

⁴ Paragraph 159 – prepare a Strategic Housing Land Availability Assessment to establish realistic assumptions about the availability, suitability and the likely economic viability of land to meet the identified need for housing over the plan period.

9. The Planning Practice Guidance (PPG) advises that:

"Plan makers should issue a call for potential sites and broad locations for development, which should be aimed at as wide an audience as is practicable so that those not normally involved in property development have the opportunity to contribute. This should include parish councils and neighbourhood forums, landowners, developers, businesses and relevant local interest groups, and local notification/publicity. It may be possible to include notification of a call for sites in other local authority documentation (such as notification of local elections) to minimise costs."

- 10. The Council undertook a SHLAA⁵ in 2012 to inform the preparation of the SLP 2013. In order to ensure there is an up to date evidence base for the Local Plan Review, the Council published a new land availability assessment alongside the Draft Local Plan in 2016.
- 11. The new availability assessment is a joint housing and economic land availability assessment undertaken in accordance with methodology set out in the PPG. Consultants (Peter Brett Associates) were commissioned to undertake the SHELAA for the Council. Their report⁶ and appendices⁷ (dated November 2016) can be found on the Council's web site.
- 12. The 2016 SHELAA assessed all the sites submitted by 13th May 2016 through the 'call for sites' exercise.

What Sites Have Been Included?

- 13. This schedule lists all those sites contained in the May 2016 schedule (numbered 1 to 245) and now includes the additional sites that have been put forward. These are numbered from 300 onwards so that it is clear that any numbered from this point are additional sites.
- 14. It should be noted that although included under the call for sites exercise, some representations to the Draft Local Plan consultation included submissions that promoted development in the Green Belt and made a suggestion as to the area of land that ought to be released from the Green Belt. It is not necessarily the case that those promoting a site or Green belt land release are suggesting that the whole of the site should be developed, rather that they have identified what they believe to be appropriate boundaries for release of land from the Green Belt. This will mean that some areas will contain uses and properties that are not expected to be included in any redevelopment proposals.
- 15. It must be stressed that the Council has not yet undertaken any assessment of these additional sites and it has not yet come to a view on whether they will be considered suitable for development (either for the use suggested by the promoter or any other use). The information contained in this publication should be treated accordingly.

Next Steps

16. The next stage in the plan making process will be for the Council to publish to submission version of the local plan for further consultation. Alongside which the Local Plan Review evidence base will be updated. This will include any appropriate update to the SHELAA that may be necessary as a result of the additional sites submitted since the November 2016 SHELAA was prepared.




