

COVID-19 - Solihull Data Summary, 30th July 2021

Summary


- The number of new cases was 1106 in the 7 days to 24th July, a rate of 511.2 per 100,000 population, a decrease of 44% on the previous 7 days.
- Information about Covid vaccine uptake by age group and electoral ward is given in this bulletin.
- At 28th July, there were 194 Covid positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with 171 on 21st July.
- There was one Covid related death of Solihull residents in w/e 16th July (deaths registered up to 24th July). (Source: ONS).

Weekly Cases and Rates

COVID-19 cases are identified by taking specimens from people and sending them to laboratories around the UK to be tested. If the test is positive, this is referred to as a lab-confirmed case.

New Cases


In the 7 days to 24th July, Solihull had 1106 new lab-confirmed cases, a rate of 511.2 per 100,000 population. This was a decrease of 44% on the previous 7 days.





The breakdown of cases in Solihull by week over time is shown below. It should be noted that case numbers prior to May 2020 are not directly comparable as there was much more restricted access to testing at that time.


Number of weekly Covid-19 cases in Solihull since 13 March (week ending), Total cases to date = 21216



Total Cases

Week Ending

The total number of lab-confirmed cases in Solihull since the start of the pandemic was 21217 at 28th July. Number of New Cases by Ward

The table below shows the number of new lab-confirmed cases by ward for the 14 days between 15th July and 28th July 2021. The number of new cases in the previous 14 days is also shown for comparison. It should be noted that, as electoral wards are relatively small areas, the wards with highest and lowest number of cases are liable to change.

Reproduction Number (Rt)

The reproduction number is the number of people that one infected person will pass on a virus to, on average. If the reproduction number is higher than one, then the number of cases increase exponentially. If the number is lower the disease will eventually stop spreading, as not enough new people are being infected to sustain the outbreak. Hospital Inpatients

At 28th July, there were 194 Covid positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with 171 on 21st July. This includes 33 in Intensive Treatment / High Dependency Units, compared with 26 on 21st July. This will include a number of Solihull residents although the majority will be Birmingham residents (source: UHB Inpatient reports, 21st July and 28th July).

Weekly Death Registrations and Occurrences (latest data published covers deaths occurred up to 16th July and registered up to 24th July 2021)

As of the week ending 16th July, there have been 654 deaths of Solihull residents that mention COVID-19. One COVID-19 death occurred in the latest week.
