

## COVID-19 - Solihull Data Summary, 6th August 2021

#### **Summary**


- The number of new cases was 769 in the 7 days to 31<sup>st</sup> July, a rate of 355.4 per 100,000 population, a decrease of 30% on the previous 7 days.
- Information about Covid vaccine uptake by age group and electoral ward is given in this bulletin.
- At 4<sup>th</sup> August, there were 175 Covid positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with 194 on 28<sup>th</sup> July.
- There were no Covid related deaths of Solihull residents in w/e 23<sup>rd</sup> July (deaths registered up to 31<sup>st</sup> July). (Source: ONS).

#### **Weekly Cases and Rates**

COVID-19 cases are identified by taking specimens from people and sending them to laboratories around the UK to be tested. If the test is positive, this is referred to as a lab-confirmed case.

#### **New Cases**


In the 7 days to 31<sup>st</sup> July, Solihull had 769 new lab-confirmed cases, a rate of 355.4 per 100,000 population. This was a decrease of 30% on the previous 7 days.





The breakdown of cases in Solihull by week over time is shown below. It should be noted that case numbers prior to May 2020 are not directly comparable as there was much more restricted access to testing at that time.

# Number of weekly Covid-19 cases in Solihull since 13 March (week ending), Total cases to date = 21946



#### **Total Cases**

The total number of lab-confirmed cases in Solihull since the start of the pandemic was 21947 at 5<sup>th</sup> August. #### **Number of New Cases by Ward**

The table below shows the number of new lab-confirmed cases by ward for the 14 days between 22<sup>nd</sup> July and 4<sup>th</sup> August 2021. The number of new cases in the previous 14 days is also shown for comparison. It should be noted that, as electoral wards are relatively small areas, the wards with highest and lowest number of cases are liable to change.

#### **Reproduction Number (Rt)**

The reproduction number is the number of people that one infected person will pass on a virus to, on average. If the reproduction number is higher than one, then the number of cases increase exponentially. If the number is lower the disease will eventually stop spreading, as not enough new people are being infected to sustain the outbreak. ### **Vaccinations**

#### **Hospital Inpatients**

At 4<sup>th</sup> August, there were 175 Covid positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with 194 on 28<sup>th</sup> July. This includes 31 in Intensive Treatment / High Dependency Units, compared with 33 on 28<sup>th</sup> July. This will include a number of Solihull residents although the majority will be Birmingham residents (source: UHB Inpatient reports, 4<sup>th</sup> August and 28<sup>th</sup> July).

Weekly Death Registrations and Occurrences (latest data published covers deaths occurred up to 23<sup>rd</sup> July and registered up to 31<sup>st</sup> July 2021)

As of the week ending 23<sup>rd</sup> July, there have been 656 deaths of Solihull residents that mention COVID-19. No COVID-19 deaths occurred in the latest week.
