The proposals are:

## <u>Proposed Total Prohibition of Waiting – No Waiting at Any Time and Restriction of Loading - Monday to Friday - 8.30am to 9.30am and 3.00pm to 4.00pm</u>

<u>Cheveridge Close (north west side)</u> – (i) From Grandborough Drive north eastwards for approx. 30m; and (ii) From a point approx. 65m north east of Grandborough Drive north eastwards for approx. 15m.

Cheveridge Close (south east side) - From Grandborough Drive north eastwards for approx. 79m.

<u>Grandborough Drive (north east & south east sides)</u> - From Whitefields Road south eastwards then south westwards for approx. 185m.

<u>Grandborough Drive (south west side)</u> - From Whitefields Road south eastwards for approx. 40m.

<u>Grandborough Drive (south west and north west sides)</u> - From a point approx. 93m south east Whitefields Road, south eastwards, then south westwards for approx. 80m.

Northwick Crescent (both sides) - From Grandborough Drive north eastwards for approx. 15m.

<u>Whitefields Road (south east side)</u> - From a point approx. 40 metres southwest of Grandborough Drive north eastwards for approx. 80m.

## <u>Proposed Restriction of Waiting - Monday to Friday - 9.00am to 11.00am and 2.00pm to 3.00pm</u>

Ashton Croft - From Grandborough Drive for its entirely.

<u>Cheveridge Close (north west side)</u> - From a point approx. 30m north east of Grandborough Drive north eastwards for approx. 35m.

<u>Grandborough Drive (south west side)</u> - From a point approx. 40m south east of Whitefields Road south eastwards for approx. 53m.

<u>Grandborough Drive (both sides)</u> - From a point approx. 50m south west of Northwick Crescent south eastwards then north eastwards and north for its entirety.

Hollyoak Grove - From Grandborough Drive for its entirely.

Northwick Crescent - From a point approx. 15m north east of Grandborough Drive for its entirety.

To facilitate the above, all existing provisions and as far as they apply to Traffic Regulation Orders made by the Metropolitan Borough of Solihull shall hereby be revoked or amended as deemed necessary for the purposes of this proposed Order.
