The proposals are:

## <u>Proposed Total Prohibition of Waiting – No Waiting at Any Time and Prohibition of Loading - Monday to Friday - 8.30am to 9.30am and 2.30pm to 4.00pm</u>

Eastcote Close (both sides) - From its junction with Lawnswood Avenue for its entirety.

<u>Freasley Close (both sides)</u> - From its junction with Lawnswood Avenue south westwards for approx. 15m.

<u>Lawnswood Avenue (both sides)</u> – (i) From its junction with Radbourne Road south westwards for approx. 15m; and (ii) From a point approx. 20 north east of its junction with Eastcote Close south westwards for approx. 40m.

<u>Lawnswood Avenue (west side)</u> - From a point approx. 20m north of its junction with Newnham Rise southwards for approx. 40m.

<u>Lawnswood Avenue (south west side)</u> - From a point approx. 15m north west of its junction with Freasley Close south eastwards for approx. 30m.

Newnham Rise (both sides) - From its junction with Lawnswood Avenue westwards for approx. 30m.

<u>Radbourne Road (both sides)</u> - From a point approx. 20m north west of its junction with Lawnswood Avenue south eastwards for approx. 45m.

## Proposed Restriction of Waiting - Monday to Friday 8.30am - 9.30am and 2.30pm - 4.00pm

<u>Lawnswood Avenue (south east side)</u> - From a point approx. 20m south west of its junction with Radbourne Road south westwards for approx. 81m.

<u>Lawnswood Avenue (east and north east sides)</u> - From a point approx. 20m south of its junction with Eastcote Close south then south eastwards for approx. 226m.

To facilitate the above, all existing provisions and as far as they apply to Traffic Regulation Orders made by the Metropolitan Borough of Solihull shall hereby be revoked or amended as deemed necessary for the purposes of this proposed Order.
