

## COVID-19 – Solihull Data Summary, 4<sup>th</sup> February 2022

### Summary

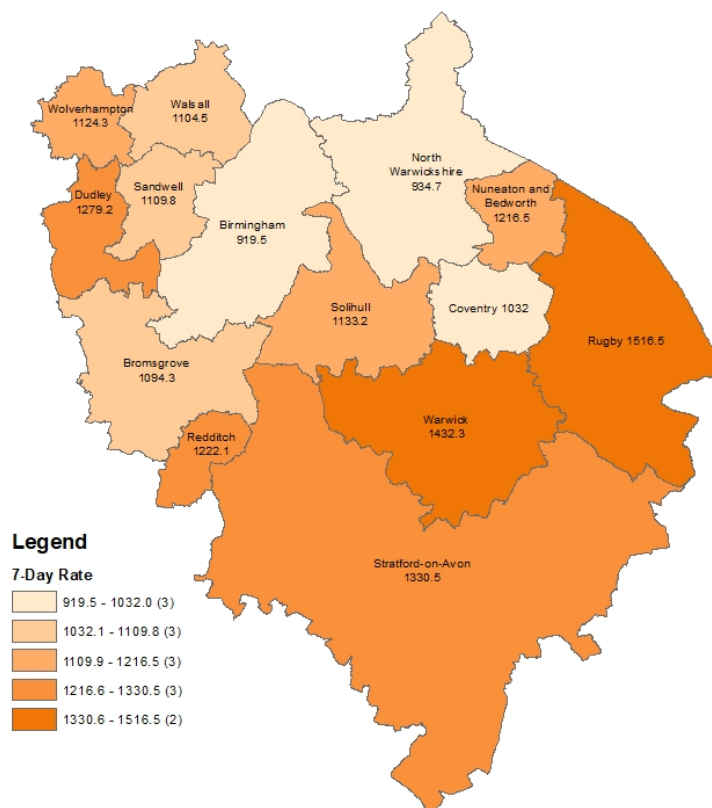
- The number of new cases was **2,452** in the 7 days to **28<sup>th</sup> January**, a rate of **1133.2** per 100,000 population, a decrease of **14%** on the previous 7 days.
- Information about COVID-19 vaccine uptake by cohort and electoral ward is given in this bulletin.
- At **3<sup>rd</sup> February**, there were **379** COVID-19 positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with **443** on **27<sup>th</sup> January**.
- There were **4** COVID-19 related death(s) of a Solihull resident in **w/e 21<sup>st</sup> January** (deaths registered up to **29<sup>th</sup> January**). (Source: ONS).

### Weekly Cases and Rates

COVID-19 cases are defined as an individual with at least one confirmed positive test from a polymerase chain reaction (PCR), rapid lateral flow test (LFT) or loop-mediated isothermal amplification (LAMP) test. Positive rapid lateral flow test results can be confirmed with PCR tests taken within 72 hours. If the PCR test results are negative, these are not reported as cases.

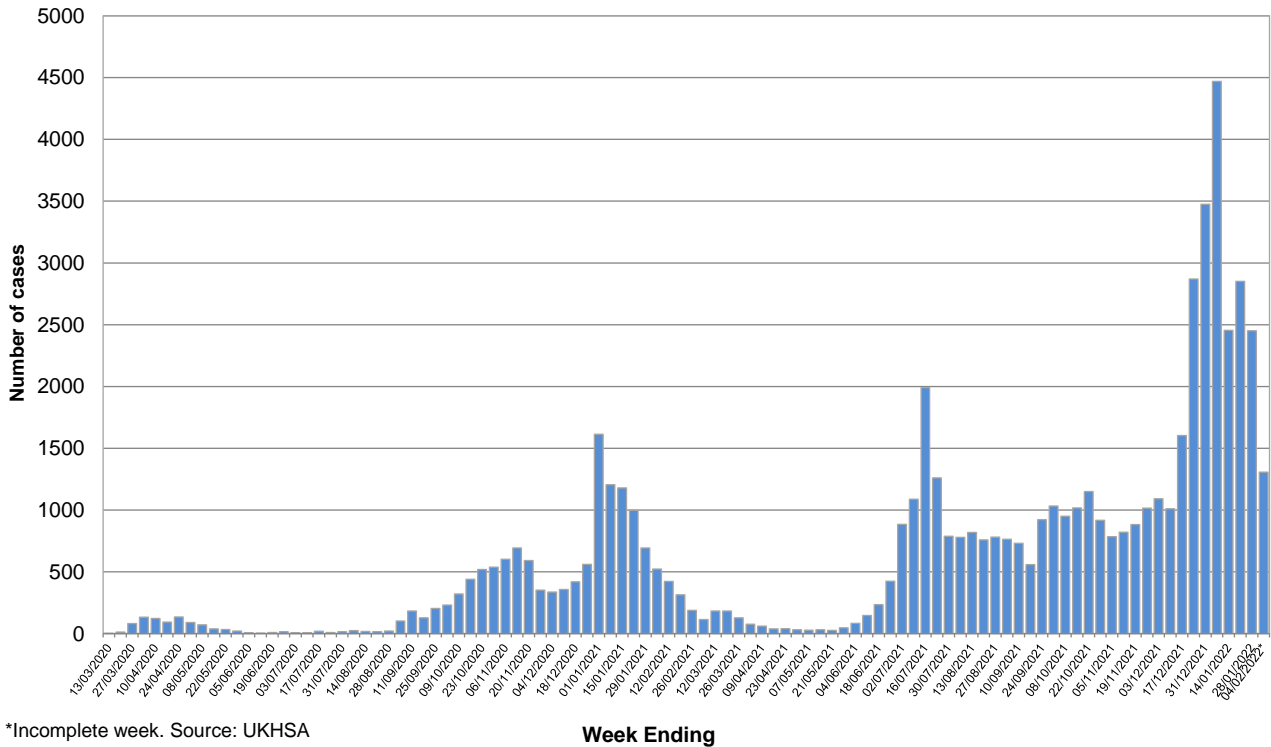
### New Cases

In the 7 days to **28<sup>th</sup> January**, Solihull had **2,452** COVID-19 cases, a rate of **1133.2** per 100,000 population. This was a decrease of **14%** on the previous 7 days.



The breakdown of cases in Solihull by week over time is shown below. It should be noted that case numbers prior to May 2020 are not directly comparable as there was much more restricted access to testing at that time.

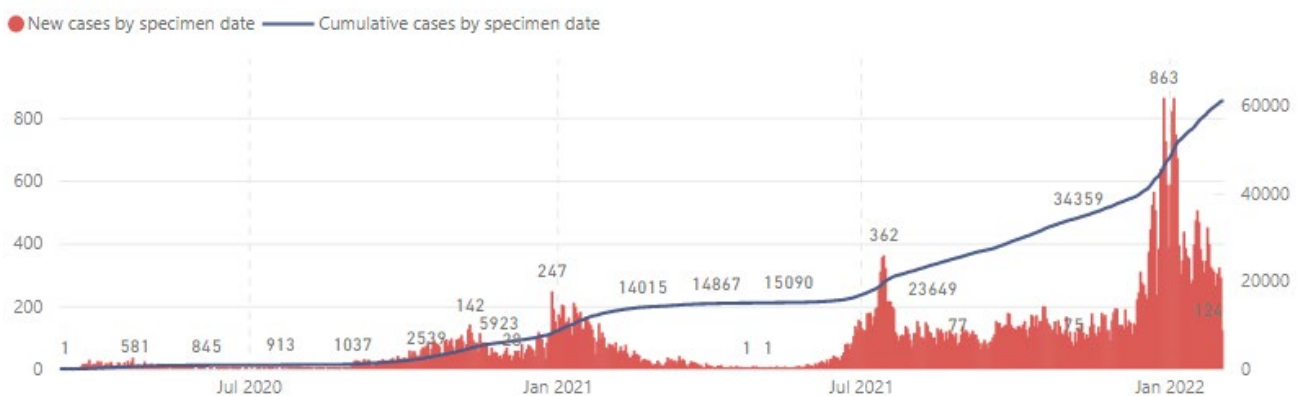
### Number of weekly COVID-19 cases in Solihull since 13 March 2020 (week ending)



### Total Cases

The total number of lab-confirmed cases in Solihull since the start of the pandemic was **60,912** on **2<sup>nd</sup> February**. ### Number of New Cases by Ward

The table below shows the number of new lab-confirmed cases by ward for the 14 days **between 17<sup>th</sup> January and 30<sup>th</sup> January 2022**. The number of new cases in the previous 14 days is also shown for comparison. It should be noted that, as electoral wards are relatively small areas, the wards with highest and lowest number of cases are liable to change.

### Reproduction Number (Rt)

The reproduction number is the number of people that one infected person will pass on a virus to, on average. If the reproduction number is higher than one, then the number of cases increase exponentially. If the number is lower the disease will eventually stop spreading, as not enough new people are being infected to sustain the outbreak. ## Vaccinations

The table below shows coverage of the first dose of the COVID-19 vaccine by age group, priority group, and electoral ward at **31<sup>st</sup> January 2022**. Data is on Birmingham and Solihull CCG registered patients who are resident within Solihull.

A third dose of COVID-19 vaccine is given to people with a weakened immune system and is different to a COVID-19 booster dose. Uptake is calculated using the current population eligible for a booster or a third dose.

## Hospital Inpatients

At **3<sup>rd</sup> February**, there were **379** COVID-19 positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with **443** on **27<sup>th</sup> January**. This includes **19** in Intensive Treatment / High Dependency Units, compared with **23** on **27<sup>th</sup> January**. This will include a number of Solihull residents although the majority will be Birmingham residents (source: UHB Inpatient reports, **27<sup>th</sup> January** and **3<sup>rd</sup> February**).

**Weekly Death Registrations and Occurrences** (latest data published covers deaths occurred up to **21<sup>st</sup> January** and registered up to **29<sup>th</sup> January 2022**)

As of the week ending **21<sup>st</sup> January**, there have been **728** deaths of Solihull residents that mention COVID-19. **4** COVID-19 death(s) occurred in the latest week.
