

# COVID-19 – Solihull Data Summary, 18th February 2022

# Summary


- The number of new cases was **1,196** in the 7 days to **11**<sup>th</sup> February, a rate of **552.8** per 100,000 population, a decrease of **36%** on the previous 7 days.
- Information about COVID-19 vaccine uptake by cohort and electoral ward is given in this bulletin.
- At 17<sup>th</sup> February, there were 275 COVID-19 positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with 336 on 10<sup>th</sup> February.
- There was 1 COVID-19 related death(s) of a Solihull resident in w/e 4<sup>th</sup> February (deaths registered up to 12<sup>th</sup> February) (Source: ONS).

## Weekly Cases and Rates

COVID-19 cases are defined as an individual with at least one confirmed positive test from a polymerase chain reaction (PCR), rapid lateral flow test (LFT) or loop-mediated isothermal amplification (LAMP) test. Positive rapid lateral flow test results can be confirmed with PCR tests taken within 72 hours. If the PCR test results are negative, these are not reported as cases. Case data now includes data on reinfections, a COVID-19 infection will be counted as a second case if there has been at least 90 days between positive test results.


## **New Cases**

In the 7 days to **11**<sup>th</sup> **February**, Solihull had **1,196** COVID-19 cases, a rate of **552.8** per 100,000 population. This was a decrease of **36%** on the previous 7 days.





The breakdown of cases in Solihull by week over time is shown below. It should be noted that case numbers prior to May 2020 are not directly comparable as there was much more restricted access to testing at that time.




# Number of weekly COVID-19 cases in Solihull since 13 March 2020 (week ending)

# **Total Cases**

The total number of lab-confirmed cases in Solihull since the start of the pandemic was **63,274** on **16**<sup>th</sup> **February**. #### Number of New Cases by Ward

The table below shows the number of new lab-confirmed cases by ward for the 14 days **between 31**<sup>st</sup> January and 13<sup>th</sup> February 2022. The number of new cases in the previous 14 days is also shown for comparison. It should be noted that, as electoral wards are relatively small areas, the wards with highest and lowest number of cases are liable to change.

# **Reproduction Number (Rt)**

The reproduction number is the number of people that one infected person will pass on a virus to, on average. If the reproduction number is higher than one, then the number of cases increase exponentially. If the number is lower the disease will eventually stop spreading, as not enough new people are being infected to sustain the outbreak. # Vaccinations

## **Hospital Inpatients**

At 17<sup>th</sup> February, there were 275 COVID-19 positive inpatients in University Hospitals Birmingham NHS Foundation Trust hospitals, compared with 336 on 10<sup>th</sup> February. This includes 9 in Intensive Treatment / High Dependency Units, compared with 14 on 10<sup>th</sup> February. This will include a number of Solihull residents although the majority will be Birmingham residents (source: UHB Inpatient reports, 10<sup>th</sup> February and 17<sup>th</sup> February).

Weekly Death Registrations and Occurrences (latest data published covers deaths occurred up to 4<sup>th</sup> February and registered up to 12<sup>th</sup> February 2022)

As of the week ending 4<sup>th</sup> February, there have been 736 deaths of Solihull residents that mention COVID-19. 1 COVID-19 death(s) occurred in the latest week.
