**SOLIHULL METROPOLITAN BOROUGH COUNCIL (PARISH OF BARSTON)  
(FOOTPATH M126A) DEFINITIVE MAP MODIFICATION ORDER 2022**

This Order is made by the Solihull Metropolitan Borough Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that Authority that the Definitive Map & Statement of Public Rights of Way for Solihull Metropolitan Borough Council require modification in consequence of an occurrence of an event specified in Section 53(3)(c)(i) namely the discovery of evidence which shows that there should be a public footpath recorded over land at Oak Lane Farm, Barston, as described in the Schedule.

The Authority have consulted with every local authority whose area includes the land to which the Order relates.

The Solihull Metropolitan Borough Council hereby order that: -

1. For the purposes of this Order the relevant date is the 30<sup>th</sup> March 2022.
2. The Definitive Map & Statement of Public Rights of Way for Solihull Metropolitan Borough Council shall be modified as described in Parts 1 and 2 of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Solihull Metropolitan Borough Council (Parish of Barston) (Footpath M126A) Definitive Map Modification Order 2022.

## SCHEDULE

### PART 1

#### MODIFICATION OF DEFINITIVE MAP

##### **Description of Footpath to be added:**

Commences at the eastern end of the sealed-surface length of Oak Lane at the entrance to Oak Lane Farm (at OS Grid Ref SP 20886,78728) at Point A on the attached plan. The Footpath leads in a north-easterly direction through a boundary into the garden of a barn conversion dwelling to another boundary at Point B (at OS Grid Ref SP 20945,78749) then leads through a small field beyond to a further boundary at Point C (at OS Grid Ref SP 21034,78786) following the south side of the northern boundaries. The footpath then continues in the same north-easterly direction within a larger field to Point D (at OS Grid Ref SP 21200,78850) where it turns in an easterly direction to lead to another boundary and a watercourse at Point E (at OS Grid Ref SP 21310,78844) and continues in the same easterly direction across a further field to Point F at a junction with Ryton End Lane (at OS Grid Ref SP 21497,78820).

### PART 2

#### MODIFICATION OF DEFINITIVE STATEMENT

##### **Description of Footpath to be added:**

Footpath M126A, commencing at the eastern end of the sealed-surface length of Oak Lane at the entrance to Oak Lane Farm (at OS Grid Ref SP 20886,78728). The footpath leads in a north-easterly direction through a boundary into the garden of a barn conversion dwelling to another boundary (at OS Grid Ref SP 20945,78749) then leads through a small field beyond to a further boundary (at OS Grid Ref SP 21034,78786) following the south side of the northern boundaries. The footpath then continues in the same north-easterly direction within a larger field to a point (at OS Grid Ref SP 21200,78850) where it turns in an easterly direction to lead to another boundary and a watercourse (at OS Grid Ref SP 21310,78844) and continues in the same easterly direction across a further field to a junction with Ryton End Lane (at OS Grid Ref SP 21497,78820).

Total length is approximately 640 metres.

Width is:

- (i) 2 metres from the start point (at OS Grid Ref SP 20886,78728) to the end point at the junction with Ryton End Lane (at OS Grid Ref SP 21497,78820).

Limitations:

1. Gates are required at the following points, at a minimum width of 1.5 metres, and constructed to BS standard BS5709:2018:
  - (i) OS Grid Ref SP 20886,78728
  - (ii) OS Grid Ref SP 20945,78749
  - (iii) OS Grid Ref SP 21034,78786
  - (iv) OS Grid Ref SP 21310,78844
  - (v) OS Grid Ref SP 21497,78820
2. A footbridge is required across the watercourse at OS Grid Ref SP 21310,78844
