

# NOTICE OF ELECTION

## UK Parliamentary Election for the Solihull West and Shirley Constituency

1. An Election is to be held of a Member of Parliament to serve Solihull West and Shirley.
2. Forms of nomination for the Parliamentary Election may be obtained at Electoral Services, Council House, Manor Square, Solihull, West Midlands, B91 3QB from the Acting Returning Officer who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
3. Nomination papers must be delivered to the Acting Returning Officer, Electoral Services, Council House, Manor Square, Solihull, West Midlands, B91 3QB on any day after the date of this notice between the hours of 10 am and 4 pm but no later than 4 pm on Friday, 7th June 2024.
4. The required deposit (£500) may be made either by the deposit of any legal tender (cash in British pounds only), by means of a banker's draft or, by electronic transfer (BACS), as below
