Proposed Total Prohibition of Waiting – At Any Time

<u>Badger Close (north-west side)</u> - From a point approx. 15m south-west of its junction with Cheswick Way, south-westwards for approx. 13m.

<u>Beechwood Close (both sides)</u> - From its junction with Foxland Close, south-eastwards for approx. 3m.

<u>Boscobel Road (south-east side)</u> - From its junction with Saxon Wood Road, north-eastwards for approx. 13m.

<u>Boscobel Road (north-west side)</u> - From its junction with Saxon Wood Road, north-eastwards for approx. 68m.

<u>Briarwood Close (north-east side)</u> - From its junction with Foxland Close, south-eastwards for approx. 24m

<u>Briarwood Close (south-west side)</u> - From its junction with Foxland Close, south-eastwards for approx. 19m.

<u>Cheswick Way (both sides)</u> - From a point approx. 35m north of its junction with Willow Drive, southwards for approx. 96m.

<u>Cheswick Way (west side)</u> - From a point approx. 20m north of its junction with Coppice Walk, southwards for approx. 48m.

<u>Coppice Walk (north-east side)</u> - From its junction with Cheswick Way, north-westwards for approx. 21m.

<u>Coppice Walk (south-west side)</u> - From its junction with Cheswick Way, north-westwards for approx. 37m.

<u>Creynolds Lane (both sides)</u> - From a point approx. 40m south-west of its most northern junction with Cheswick Way, north-eastwards for approx. 253m.

<u>Foxland Close (south-east side)</u> - From a point approx. 16m north-east of its junction with Beechwood Close, south-westwards for approx. 30m.

<u>Foxland Close (north-west side)</u> - From a point approx. 28m north-east of its junction with Glenwood Drive, south-westwards for approx. 58m.

<u>Foxland Close (south-east side)</u> - From a point approx. 41m north-east of its junction with Briarwood Close, south-westwards for approx. 56m.

<u>Glenwood Drive (both sides)</u> - From its junction with Foxland Close, north-westwards for approx. 15m.

<u>Glenwood Drive (north-east side)</u> - From its junction with Cheswick Way, south-eastwards for approx. 22m.

<u>Glenwood Drive (south-west side)</u> - From its junction with Cheswick Way, south-eastwards for approx. 15m.

Osbourne Croft (east side) - From its junction with Boscobel Road, north-westwards for approx. 15m.

Osbourne Croft (west side) - From its junction with Boscobel Road, north-westwards for approx. 18m.

<u>Saxon Wood Road (both sides)</u> - From its junction with Cheswick Way, northwards, then northwestwards for approx. 105m.

The Pines (both sides) - From its junction with Saxon Wood Road, south-wards for approx. 18m.

Willow Drive (north side) - From its junction with Cheswick Way, westwards for approx. 23m.

Willow Drive (south side) - From its junction with Cheswick Way, westwards for approx. 15m.

<u>Proposed Restriction of Waiting - Monday to Friday (8.00am to 10.00am and 2.30pm to 4.30pm)</u>

<u>Badger Close (east side)</u> - From a point approx. 15m south-west from its junction with Cheswick Way, south-west then south-eastwards for approx. 85m.

<u>Cheswick Way (north-west side)</u> - From a point approx. 35m north of its junction with Willow Drive, north-eastwards for approx. 60m.

<u>Cheswick Way (south-east side)</u> - From a point approx. 35m north of its junction with Willow Drive, north-eastwards for approx. 73m.

<u>Foxland Close (north-west side)</u> - From a point approx. 15m south-west of its junction with Cheswick Way, south-westwards for approx. 122m.

<u>Proposed Limited Waiting – Monday to Sunday 8.00am to 6.00pm – Waiting Limited to 30 Minutes (No Return within 60 Minutes)</u>

<u>Cheswick Way (west side)</u> - From a point approx. 26m south of its junction with Coppice Walk, southwards for approx. 42m.

<u>Creynolds Lane (west side)</u> - No Waiting At Any Time - From a point approx. 36m north-east of its most northern junction with Cheswick Way, south-westwards for approx.80m.
