
Figure 1.1: Location Plan of Proposals on Green Lane	4

1. Background

- 1.1. Green Lane is a busy local residential road situated within the Shirley West Ward. An existing, desire line was observed by Officers between Haslucks Green Road and Brook Close where residents cross Green Lane to access several local amenities including Shirley Station, Sir Josiah Mason Trust and Shirley Community Church. The scheme for a controlled crossing to be implemented under the Local Network Improvement Plan 24/25 was approved at the Cabinet Decision Session for Economy and Infrastructure on Thursday 15th February 2024.
- 1.2. The Local Network Improvement Plan (LNIP) 2023/24, aims to provide highway improvement schemes, focused on the safe navigation of the highway network by pedestrians and cyclists. A plan showing the location can be seen below in Figure 1.1.

- 1.3. The proposals as advertised are detailed in the consultation plan in Appendix A.
- 1.4. The revised proposals following feedback and further design constraints work is detailed in Appendix B.
- 1.5. The proposals as advertised in the legal notice in Appendix C.

2. Representations for Consideration

2.1. The proposals were formally advertised on 20 September 2024. The closing date for the receipt of representations was 11 October 2024.



2.2. No representations were received regarding the installation of a raised Zebra Crossing on Green Lane, Shirley.

3. Other Matters for Consideration

Ward Members' Views

3.1. The Ward Members for Shirley West were informed of the proposals prior to advertising the Notice and did not submit any objections.

Democratic Services

3.2 Democratic Services have confirmed that the notice was subject to the statutory advertisement on the dates reported and that no representations were received (as noted above).

Risk Implications

- 3.3 The Corporate Risk Management Approach has been complied with to identify and assess the significant risks associated with this decision/project. This includes (but is not limited to) political, legislation and reputation risks.
- 3.4 The Approach is not intended to eliminate all risks and not all the risks identified can be managed all of the time. Also, risks will still exist that have not been identified.

4. Recommendations for Decision

Officer Recommendations

- 4.1. Following the period of statutory consultation, the provision of uncontrolled crossing points at the junction of Green Lane and Brook Close has been removed from the scheme extents due to the presence of utilities in the footways which render them unviable within the current budget allocation. Officers have looked at relocating this facility further onto Brook Close, but that would marshal pedestrians off the desire line and there are also further utility constraints and a driveway access.
- 4.2. Following the period of statutory consultation, the design (as shown in Appendix B) was revisited as it created an adverse impact on parking in front of two properties on Green Lane. Following further design review work, Officers concluded that the crossing could be moved further south along Green Lane towards Haslucks Green Road. The opportunity eliminates the impact of the crossing extents on residential frontages and therefore the proposed raised zebra crossing has been relocated 12m east of the originally advertised location.
- 4.3. As there were no representations to the scheme, it is recommended to be implemented as per Drawing no. 236213-SMBC-GEN-DR-P-0001 shown in Appendix B.

For Decision

- 4.4. The Head of Highway Infrastructure is asked to approve:
- 4.5. The installation of Traffic Calming Measures (Raised table) and Establishment of a Zebra Pedestrian Crossing is implemented.

The recommendation as set out above is hereby approved:




