Alteration description

4. A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

This proposal seeks an expansion of St Augustine's Catholic Primary School by enlargement. The school currently has a capacity of 210 places (30 places per year) and is currently operating at full capacity within each year group.

This proposal is to expand the school permanently to 420 places, 60 places per year, over a 7 year period. The school will increase their intake to 60 pupils per year with effect from 1 September 2020, becoming a full two-form entry school by September 2026.

Expansion to the school building is proposed.

School capacity

In addition the school has capacity for up to 26 part-time nursery pupils.

The growth of the school will be gradual with an additional class being admitted at Reception each year until the school reaches its capacity.

(c) where it is intended that proposals should be implemented in stages, the number of pupils to be admitted to the school in the first school year in which each stage will have been implemented;

This proposal is for permanent expansion at the school by 30 pupils per year, admitted at Reception, from 1 September 2020.

At the time of publication, the total number of pupils on roll was: **211** plus **23** part-time nursery pupils.

Implementation

6. This proposal relates to a voluntary aided school and is to be implemented by the Council, in partnership with the Governing Body. The Council is managing and procuring the expansion of the school building. The Governing Body of the School will implement the increase in pupil numbers through an increase in admissions to the school.

7.Additional Site

No additional site is required for the proposal.

8. Changes in boarding arrangements

The proposal does not make any changes to boarding arrangements.

9.Transfer to new site

This proposal does not require the school to transfer to a new site.

10. Objectives

The objectives of these proposals are:

We are proposing to expand St Augustine's Catholic Primary School so that the school will be able to admit 60 pupils each year across Reception to Year 6 and remain with 26 part-time nursery places in September 2020. The growth of the school will be gradual.

An increase in primary Catholic school places will ensure that parental preference for primary Catholic school places can be met, both now and in the future, as approved housing developments in the wider area are completed. It is expected that the School will be able to admit those Catholic families living outside of the Parish but where St Augustine's Catholic School is their closest Catholic School. This 'shuffle' of school places will create spaces in other primary Catholic Schools for those families moving into the new development therefore maximising parental preference.

St Augustine's Catholic Primary School was rated as 'Good' with outstanding Leadership by Ofsted in March 2019, and will enhance the number of places offered in good and outstanding schools in Solihull.

11.Consultation

All requirements in relation to the proposal to consult have been complied with. All interested parties have been consulted and their views considered by the Cabinet Portfolio Holder for Children, Education and Skills before this statutory proposal was published. The full report outlining the pre statutory consultation process that has been undertaken can be found on the website at www.solihull.gov.uk/consultation

The main concerns raised through the consultation process were around traffic congestion, parking and air pollution. The Council has commissioned an independent travel assessment as part of this process. This will be submitted as part of the planning application so that traffic and parking can be given full consideration by Planning Committee when considering whether to allow expansion of the school building on the school site. The planning application will be determined, in part, by the mitigation offered to support this proposal.

12.Project costs

A statement of the estimated total capital cost of the proposals and the breakdown of the costs that are to be met by the governing body, the local education authority, and any other party.

The established budgetary provision for the progression of this proposal is contained within the Children's Services Capital Programme and funded by basic need grant paid to Solihull Council by the Government. An expansion of an existing school is the most cost effective way of creating the additional 210 places required.

The provisional budget based upon the feasibility scheme for the school is:

All costs outlined in **12** above will be met by Solihull Metropolitan Borough Councils Children's Services Capital Programme.

14. Age Range

No change is proposed to the age range of the school as part of this proposal.

15. Early Years Provision

No change is proposed to the lower age limit of the school.

16. Changes to Sixth Form Provision

This school is a primary school so no change is proposed to sixth form provision.

17. Special educational needs

No change is proposed to provision for special educational needs.

18. Sex of Pupils

No change is proposed.

19. Extended Services

This proposal does not change the extended services currently being offered by the school.

20. Need or demand for additional places

If the proposals involve adding places—

(a) a statement and supporting evidence of the need or demand for the particular places in the area;

This proposal is based on there being a clear business case to meet an increasing demand for primary Catholic school places, including additional Catholic demand from the housing development at Blythe Valley, Tidbury Green and Shirley.

Following initial site feasibility work carried out by the Catholic Diocese, St Augustine's is identified as their preferred primary school to expand to meet the demand for Catholic places. The Diocese confirmed their support for this expansion through the consultation process.

Current school admissions data and forecast pupil demand indicates that there is a need to provide additional Catholic primary school places, in order to ensure both sufficiency of school places in Solihull and to meet current and future parental preference for a Catholic primary school place.

The Council is committed to maintaining proportionality of church school places in Solihull and works in partnership with both the Catholic and Church of England Diocese. The diversity of school places in a relevant area is part of the Department for Education statutory guidance to decision makers when considering proposals such as this one.
