Dear Sir/Madam,

I am pleased to inform you that the Council has published its Gypsy and Traveller Site Allocations Development Plan Document (DPD) Submission Draft for a six week period of representation prior to its submission to the Secretary of State for independent examination.

The document sets out the Council's approach to meeting the identified need for Gypsy and Traveller pitches across the whole Borough over the period to 2027 and includes the identification of sites that the Council considers suitable to meet these requirements. It also includes planning policies against which applications for Gypsy and Traveller associated development will be determined.

The Council is identifying 4 sites to accommodate 31 pitches in the Borough, to be delivered in two phases as follows:
