### **Proposed Modifications 1-6**

1.	Proposed nil rate for residential use class (C3) for Blythe Valley Park
	I object — The CIL Levy is intended to fund projects and provide much needed infrastructure in the Borough. It has been set at a modest level which should be applied uniformly according to the adopted rules. The purpose of the levy is to offset a small part of the cost of providing new infrastructure.
	It seems very unlikely that the levy would render the Blythe Valley development uneconomic. Waiving the levy in the current case would set a bad precedent.
	Developers know what the system is, and it is part of the commercial environment in which they have to operate. It would be unfair to favour one developer over another, and would be against Government policy to get developers to pay a small part of the cost associated with the provision of infrastructure for new house occupiers.
	In addition, with the extreme shortage of funds for local council activities, every possible source of funding should be pursued.






