### **Safeguarding Adults Board**

The Solihull Safeguarding Adults Board was established in June 2008. The Board is made up of nominated lead officers from key organisations within the Solihull area, and includes those organisations that have statutory responsibilities in promoting the welfare of adults and protecting adults whose independence is placed at risk by abuse & neglect.

The role of the Solihull Safeguarding Adults Board is to maintain and develop interagency frameworks to safeguard adults within Solihull, and to co-ordinate what is done by each person or body represented on the Board in relation to the safeguarding of adults. The purpose of this Sub Committee is:

- · Development, review and revision of policies and procedures
- Effective multi-agency working
- Training and Education
- Development of Commissioning, Contracting and Contract monitoring process
- Identification of gaps and new initiatives needed to ensure the safeguarding agenda is achieved

- Make links with SMBC Community Safety team, LSCB and Domestic Violence.

The Prevention Sub Committee is chaired by Anne Hastings, Chief Executive Officer for Age UK Solihull and the group is made up of representatives from Enable Solihull, Carers Centre, SCOPE, SMBC Public Protection, WM Police, Solihull Care Trust, Not for Profit Group, Solihull Action through Advocacy.

The Prevention Sub-Committee meets not less than four times a year between Board Meetings, with additional meetings arranged as necessary to meet reporting and delivery requirements.



## **Quality and Audit Sub Committee**

The purpose of this sub committee is:

- Data analysis
- · Serious case reviews
- Ensuring learning from national and local enquiries
- Quality Audits

The sub committee is chaired by Margot Warner – Solihull NHS Primary Care Trust. The sub committee is made up of representatives from SMBC, BSMHFT, HEFT, C&WPT, WM Police, WM Ambulance Service and the Private & Voluntary Sector.

The Quality and Audit Sub-Committee meets not less than four times a year between Board Meetings, with additional meetings arranged as necessary to meet reporting and delivery requirements.

## **Training and Workforce Development Sub Committee**

The Purpose of the Training and Workforce Development Sub Committee is:

- To develop high quality multi agency training to ensure staff implementing the Safeguarding Adults multi agency procedures have the skills, knowledge and competence.
- To develop training for providers of services so their practices Safeguard adults at risk of harm.
- To carry out training needs analysis to inform multi agency training programmes.
- To develop a competency based framework and accreditation process for key staff required by their role to lead Safeguarding Adults procedures.

The sub committee is chaired by Joan Mchugh – SMBC Workforce Development Manager. The sub committee is made up of representatives from SMBC – Adult Social Care, HEFT, BSMHFT, C&WPT, WM Police, Solihull PCT and a Representative SWIDCA.

The Training and Workforce Development Sub-Committee meets not less than four times a year between Board Meetings, with additional meetings arranged as necessary to meet reporting and delivery requirements.



# MCA & DOLS Local Implementation Steering Group

The Purpose of the MCA & DoLS Local Implementation Steering Group is:

- To organise and arrange appropriate numbers and training for BIA's and managing authorities.
- To consider case law and how it affects MCA & DoLS and how best to cascade that information to partner agencies.
- To be responsible for maintaining appropriate data and figures of applications and authorisations so as to ensure compliance with DH regulations.
- To consider case studies and BIA work to ensure a consistency of approach and quality of service.
- To devise appropriate policies and procedures that can be implemented across the partner agencies.

This group is chaired by Lyn Andrews – SMBC Safeguarding Adults, MCA and DoLS Operational Coordinator. The group is made up of representatives from Solihull Adult Social Care, Solihull PCT, BSMHFT, West Midlands Police, SCH, West Midlands Ambulance Service, HEFT and a Representative from Private and Voluntary Sector providers.
